II. PUBLIC COMMENTS

*Persons who have complaints against Board members or District staff are encouraged to seek resolution to those complaints by using the San Pasqual Valley Unified School District written complaint procedures before orally addressing them at a meeting. The Board will not respond to such complaints until the applicable complaint procedure (BP/AR 1312.1) has been followed and has reached the Board level. Where a complaint concerns a District employee identifiable by name, position, or other facts, the Board cannot respond until proper written notice has been given to the employee pursuant to Government Code Section 54957.

Because this is a special board meeting with a limited agenda, public comment shall be limited to only those subjects described in the agenda. Comments shall be limited to three minutes per person (six minutes if translator required) and twenty minutes (forty minutes if translator required) for all comments, per topic, unless the board president, subject to the approval of the Governing Board, sets different time limits.

2. How many students are college/career ready? Ms. Fox explained data is not yet available for this year. However last year we had 3.6% of our students categorized as college/career ready. We do not expect any major changes for this year.
3. Is the High School Principal still working with the colleges? Ms. Fox stated yes. Partnership with Arizona Western College. Need to also work with Imperial Valley College.
4. Is the Safe Route to School Grant done? Ms. Fox stated yes. All sidewalks have been completed.
