Student Dasan Lynch addressed the college campus field trips to the board. Dasan feels that all students should be allowed to attend any college campus field trip and it should not be limited just to clubs. Many students are not involved in clubs because they are involved in other activities, and he believes the opportunity to tour college campuses should be open to all students. He believes this process should start during the freshmen year in order for students to begin thinking about what they want to do when then graduate. During sophomore year they can tour specific colleges when offered through the district. Junior year should be the opportunity to finalize the decision of which college to attend. Senior year should be prep for what the needs are for the specific college chosen.
