Ms. Blackmer Bloomquist (Ms. B) presented information on the Art program. San Pasqual has 70 at the Yuma County Fair which runs from 10/15-10/23. These pieces are from the 2020 school year as they could not be presented at the Fair due to covid. Ms. B also discussed the dual credit program with AWC and currently we have 17 students enrolled in this program.

Mr. Xavier Sanders presented on the science program. He is very excited for the new curriculum and lab equipment the science program has received. This year there has been a glider competition as well as engineering challenges.

Coach Gardener presented information about the football team along with introducing assistant Coach Bijas. SPVHS is playing 11-man football this year; currently there are 20 players. Goal was to have 30 and they were close. Most of the players will be returning next year with 16 freshmen/sophomores/juniors which is excellent for the football program. Tues/Thurs is study hall from 3:30-4:30 to help keep players academically eligible. Mon/Wed/Sat is weight training and films are watched on Saturdays as well. The players have the ability to login to a football platform to watch films and view different plays. Two Captains who will be returning this year spoke and they were Elias Espinoza (Freshman) and Cesar Alvarez (Junior). They are both very excited for the development of the team.
